

**A BYLAW TO CLASSIFY, LICENSE,
REGULATE AND GOVERN BUSINESSES**

BYLAW NO. 08/08

The Council of the Northern Village of Green Lake in the Province of Saskatchewan, under the provision of Section 90.3 of *The Northern Municipalities Act*, enacts as follows:

1. In this bylaw the expression "transient trader" shall have the meaning ascribed to it by *The Northern Municipalities Act*.
2. No person shall carry on any of the businesses set out in Section 10 of this bylaw within the northern municipality unless he possess a valid and subsisting license for the purpose issued in accordance with the provisions of this bylaw.
3. The Clerk of the northern municipality is hereby authorized to issue a license to any person carrying on business in the northern municipality
 - (a) who makes application for such license stating specifically the nature of his business in the northern municipality; either permanent or transient or
 - (b) who is not assessable for the purpose of taxation in respect of that business; and
 - (c) who has complied with *The Auctioneers Act* if the same applies or may apply in respect of the license for which he has made application under this bylaw; and
 - (d) who tenders with his application the proper license fee as herein provided for.
4. Subject to the right of the Council to suspend or revoke the same, as provided by *The Northern Municipalities Act*, every license issued hereunder shall remain in force and effect until and including the thirty-first day of December of the year of issue.
5. Where a license is issued hereunder after July first of any year the fee payable under Section 10 shall be reduced by 50% percent.
6. Every license issued hereunder shall specifically state the kinds of services, goods or merchandise which the licensee is authorized to offer for sale of or take orders for as the case may be and whether in the case of goods or merchandise, he may offer the same for sale by retail or by public auction or both. Such license shall also state the restriction as set forth in Section 10 hereof.
7. No person to whom a license has been granted under this bylaw shall offer for sale services, goods or merchandise or solicit orders for future delivery of goods or merchandise within the northern municipality.
 - (a) other than of a kind or kinds described in the license; or
 - (b) by any method except as authorized therein; or
 - (c) at any time or during any period when shops within the northern municipality offering for sale or taking orders for similar services, goods or merchandise are required by the northern municipality bylaw to be and remain closed.
8. The issuing of a license to a person or corporation by the Northern Municipality does not relieve that person of the responsibility of obtaining any provincial license that may be required by law.
9. Every person licensed under this bylaw shall, at all reasonable times, upon request of the Clerk, the northern municipality constable or license inspector, or any peace officer, produce such license for inspection purposes.

10. Subject to Section 5, the fee payable for a license under this bylaw shall be as follows:

- (a) for a Direct Seller or transient traders being sellers of food stuffs, household goods, vacuums, books or magazines, insurance from door to door:
\$30.00
- (b) for a person who goes from house to house carrying on the business of a barber or hairdresser or who carries on such business at the private residence of customers or in their own home:
\$75.00
- (c) for a contractor who enters into contracts for the construction, alteration, repair or removal of buildings or structures, the installation of heating plants, plumbing or other fixtures, electric wiring, or performance of other similar work in the northern municipality:
\$150.00
- (d) for contractors in the building and excavating trades with the use of heavy equipment (backhoes, graders, cats etc.):
\$150.00
- (e) for a person who goes from house to house soliciting orders for work consisting of the dry cleaning, dyeing, glazing, cleaning, pressing, making alterations or repair of clothing or furs:
\$75.00
- (f) for a person who sells, distributes or delivers coal, wood, oil, or propane gas for use as heating fuel, by retail within the northern municipality:
\$150.00
- (g) for a person carrying on any other business within the northern municipality and which is classified as follows:
 - (1) Retail Services (gas bars, restaurants, hotels, motels, grocery stores, bed and breakfasts', convenience stores, clothing, car dealers, auto repair, etc.):
\$100.00
 - (2) Fee for Service based businesses (Bookkeeping, Barbers, Caterer, Janitorial, Delivery, Outfitting, etc.):
\$100.00
 - (3) Home based retail sale:
\$100.00
 - (4) Industrial or Manufacturing
\$200.00
 - (5) Other Services not specified or classified:
\$100.00

11. Any person who violates any provision of this bylaw is guilty of an offence and shall be liable on summary conviction to a fine:

- (a) for the first offence, of not less than \$500 and not more than \$10,000;
- (b) for a second or subsequent offence, of not less than \$1,000 and not more than \$20,000;
- (c) and the convicting judge of the Provincial Court of Saskatchewan shall order that in default of payment of a fine imposed pursuant to this bylaw, the store or business with respect to which the offence took place shall be closed until the fine is paid.

12. This bylaw shall come into force and take effect upon approval by the Minister of Municipal Affairs, repealing and replacing any former licensing bylaws of the Northern Village of Green Lake.
