## NORTHERN VILLAGE OF GREEN LAKE Drinking Water Quality and Compliance Annual Notice to Consumers

#### Introduction

Saskatchewan Environment (SE) requires that at least once each year waterworks owners provide notification to consumers of the quality of water produced and supplied as well as information on the performance of the waterworks in submitting samples as required by a Minister's Order or Permit to operate a waterworks. The following is a summary of the Northern Village of Green Lake water quality and sample submission compliance record for the January 1, 2019 - December 31, 2019 time period. This report was completed on January 13, 2020. Readers should refer to MOE's "Municipal Drinking Water Quality Monitoring Guidelines, October 2012, EPB 202" for more information on minimum sample submission requirements and the meaning of type of sample. Permit requirements for a specific waterworks may require more sampling than outlined in the department's monitoring guidelines. ### 5. Chemical - Health Category

All waterworks serving less than 5000 persons are required to submit water samples for SE's Chemical Health category once every 2 years. The Chemical Health category includes analysis for arsenic, barium, boron, cadmium, chromium, fluoride, lead, nitrate, selenium and uranium.

The last sample for Chemical Health analysis was submitted on **August 23**, **2019**. Sample results indicated that the provincial drinking water quality standards were not exceeded.

### 6. General Chemical

All waterworks serving less than 5000 persons are required to submit water samples for SE's General Chemical category once every two years. The General Chemical category includes analysis for alkalinity, bicarbonate, calcium, carbonate, chloride, conductivity, hardness (as CaCO<sub>3</sub>), magnesium, sodium, sulphate and total dissolved solids.

The last sample for General Chemical analysis was submitted on **August 24, 2017**. Samples exceeded provincial aesthetic objectives for the General Chemical category for the following parameters:

The presence of these substances will affect the acceptance of water by consumers and/or interfere with the practice of supplying good quality water. Compliance with drinking water aesthetic objectives is not mandatory as these objectives are in the range where they do not constitute a health hazard.
