AUTHORIZE MAYOR TO SIGN BUILDING CANADA FUND COMMUNITY AGREEMENT

Darwin Lafond moves that the Northern Village of Green RES #168/19 Lake support the application for a PTIC grant for Water infrastructure, namely the Water and Sewer Main Replacement and council agrees to meet legislated standards, to meet the terms and conditions of the relevant PTIC program, to conduct an open tendering process, to manage the construction of the project, to fund the municipal share of the construction cost, to fund ongoing operation and maintenance costs and to follow any mitigation measures as required by the Canadian Environmental Assessment Act and The Environmental Assessment Act. Furthermore; council appoints Sask Water as project manager for the project and authorizes Sask Water to prepare the NBCF application and administer the project on behalf of the community.

ASSIGNMENT OF COMMUNITY OPERATING GRANT

RES #169/19

Joe Gardiner moves that the Northern Village of Green Lake hereby assigns a portion of its Northern Municipal Revenue Sharing grant to the Northern Municipal Trust Account each year over a five year period starting in 2020 to continue to pay their remaining direct Municipal contribution to the Green Lake water and sewer main replacement project. The 2014 estimated project cost was \$4.2M with a direct municipal contribution of \$350,000. The village made yearly deductions of \$70,000 from 2014 to 2019 excluding 2018.

NORTHERN VILLAGE OF GREEN LAKE

It is understood that the 2019 estimated total project cost is now \$5.29M and that direct Municipal contribution is estimated to be 1912 of this or \$440,833; an increase of \$90,833. Therefore, five equal yearly deductions of \$\$18,167 from our NMRS Grant will be made by the NMTA starting October 2020 and ending October 2024. It is further understood that this project is part of the Phase V Northern Water 7 Sewer Program which is anticipated to take 5 to 7 years to complete and that the actual direct municipal contribution will be based on the final total project cost. It is understood that the above noted project estimate was determined in 2019 and that costs vary significantly from year to year due to inflation and that our municipality should expect and budget for an accumulated project increase of 3% to 5% per year. In order to account for any potential cost increases SaskWater will provide a final project cost statement to the Municipality and to the Manager of Financial Services, Ministry of Government Relations in La Ronge. Following this the Manager of Financial Services with inform the Mayor and Council of any required additional payment. Arrangements for making this payment will subsequently be discussed and agreed upon.
