GREEN LAKE FIRE DEPARTMENT RESPONSE BOUNDARY

RES #06/20 Darwin Lafond moves that the Northern Village of Green Lake restrict the response boundary of the Green Lake Volunteer Fire Brigade to 25km north on Highway 155, 30km east on Highway 55, and to the RM of Meadow Lake Boundary to the West. WES REGAN LEASE TAX ARREARS

- RES #10/20 Joe Gardiner moves the Northern Village of Green Lake has reviewed the requests of Wes Regan to alter taxes charged on tax arrears accumulated on land leased by Mr. Regan. Council is agreeable to the following:
 - Taxes prior to the signing of his lease agreement in 2001 for NE20-61-12-W3 were accumulated by his father and therefore will be abated from the tax account;
 - If the applicant signs a release returning the lease of SW16-61-12-W3 to the Northern Village of Green Lake the village will abate all associated taxes due to the inability to use the land due to flooding;
 - Council will abate taxes on SE20-61-12-W3 charge for 2015-2019, that were incorrectly assessed on land that should have been tax exempt beginning January 2015.
